Thailand is one of the countries with the fastest rates of ageing-citizen growth in Asia - reportedly second only to China -while the public and private sectors' preparations to support the rising number of seniors are not yet sufficient” Thonburi Healthcare Group chairman, Dr. Boon Vanasin said earlier this month.

**He also pointed out that only 5 percent of the current ageing Thai population were able to take care of themselves, and that a third of Thai seniors still had debts to pay. Meanwhile, the trend for younger people to move to cities for jobs caused many elderly people to stay alone at home in rural areas and develop depression and chronic ailments, he added. It is necessary to prepare people for ageing, provide preventive medicine and advice - such as exercise and a healthy diet - apply advance technology in diagnosis and treatment for illness, and provide shelter for those seniors in need of special care, in order to boost seniors' healthy living conditions, Boon stressed.**



HE SAID ARTIFICIAL INTELLIGENCE TECHNOLOGY, WHICH CAN YIELD IMMEDIATE DIAGNOSTIC RESULTS, WOULD PLAY A KEY ROLE IN FUTURE AND ALLOW TREATMENT TO BE CONDUCTED AT HOME WITHOUT THE NEED FOR THE ELDERLY TO TRAVEL TO HOSPITAL. BOON URGED THE PUBLIC SECTOR TO PROMOTE PUBLIC HEALTH POLICIES FOR SENIOR CITIZENS' WELL-BEING, RATHER THAN FOCUSING ONLY ON TREATING SERIOUS DISEASES. HE ALSO URGED THE PRIVATE SECTOR TO PAY ATTENTION TO AFTER-RETIREMENT CONSUMERS IN ORDER TO CATER TO THE MARKET'S SHIFTING DEMANDS, AND TO HELP THE GOVERNMENT FIND SOLUTIONS TO THIS CHALLENGE.

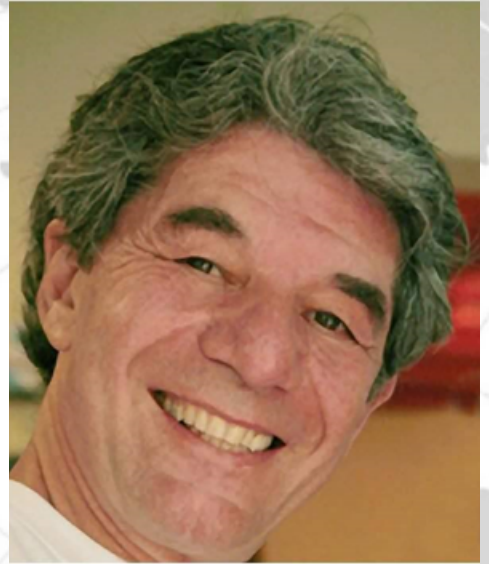

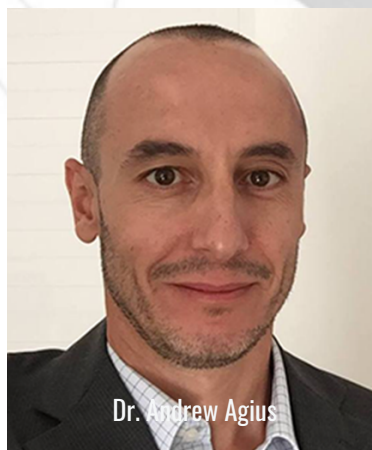

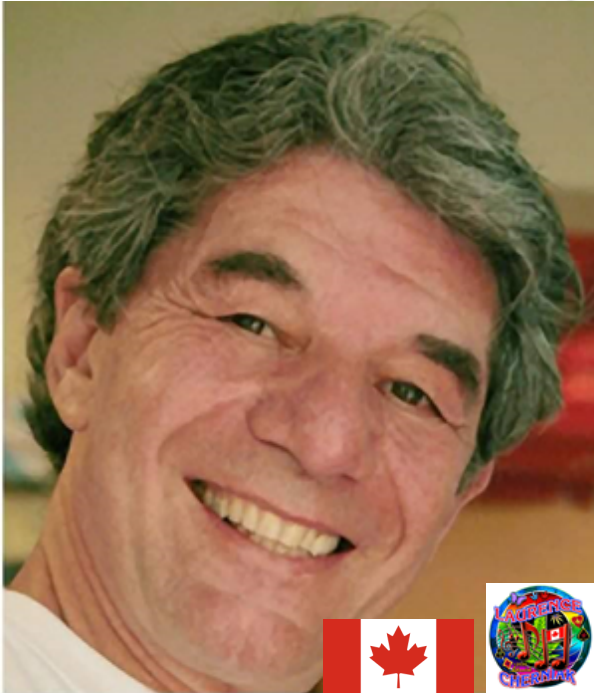

**Surang Leelawat (Ph.D.) is an assistant professor and lecturer of Department of Pharmacognosy at Rangsit University. Therefore, in January 5, 2018, 11 members of the National Assembly suggest to revise part of 'The Narcotic Drug Management Act'

On November 23, 2018, during the 364th National Assembly plenary session, "The Narcotic Drug Management Act Revision" has been passed. KMCO was built on the foundation of education and community outreach. Our passion for educating medical professionals on the therapeutic benefits of cannabis and working to bring cannabis companies and grass-roots organizations together has made KMCO a well-known and well-respected organization in the cannabis community both in Korea, and globally Strategic partnerships between commercial entities, non-profit organizations and patient advocacy groups will be a critical component of the destigmatization and successful commercialization of cannabis in Korea.

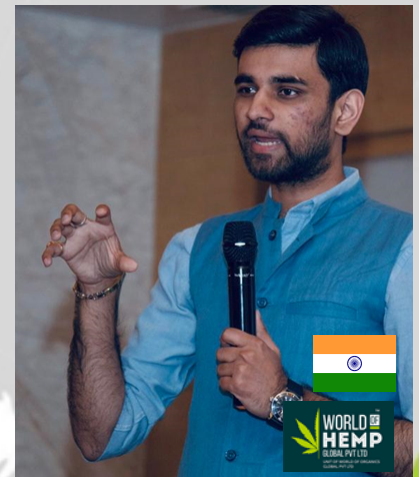
